### DOVALUE: INFORMATION ABOUT THE PURCHASE OF TREASURY SHARES BETWEEN JULY 12<sup>th</sup> AND 16<sup>th</sup>, 2021 SERVING THE MANGEGEMENT INCENTIVE PLAN 2021

**Rome, July 19<sup>th</sup>, 2021** – doValue S.p.A. (“doValue” or the “Company”) announces that between July 12<sup>th</sup> and 16<sup>th</sup>, 2021, it has acquired, on the Mercato Telematico Azionario organized and managed by Borsa Italiana S.p.A. (“MTA”), 108,940 own shares at a volume-weighted average price of Euro 8.9032 per share for a total consideration of Euro 969,911.

The transaction follows up on the announcement on June 18<sup>th</sup>, 2021, concerning the start of a share buyback program (the “Program”), implementing the authorization granted by the Shareholders’ Meeting held on April 29<sup>th</sup>, 2021, and resolved to serve the management incentive plan 2021.

On the basis of the information provided by the intermediary engaged to execute the purchases, the following table summarizes, in daily and aggregate form, doValue ordinary shares’ purchases carried out by the intermediary during the period indicated above.

Since the beginning of the Program, doValue has acquired 201,705 own shares (equal to 0.2521% of the share capital), for a total consideration of Euro 1,805,362. Considering the treasury shares already owned, doValue holds, as of July 16<sup>th</sup>, 2021, a total of 674,044 treasury shares, equal to 0.84% of the share capital.
